**Ecology of Peace UN**  
**Resolution Declaration**

I, \_\_\_\_\_ hereby declare my conditional co-operator consent to provide H 111/19: LJ v Lindiwe Sisulu [pp.70] respondents with a mandate to authorize Ecology of Peace UN Resolution [pp.25-66/70]; to implement EoP Scientific and Cultural law based on EoP Footprint as binding international law; to enable Ecology of Peace Truth and Reconciliation (“EoP TRC”) to End Abel and Kane Cold War to [A] enable responsible freedom orderly and humane – de-industrialization and depopulation, prisoner release, land reform and denuclearization – shut down of the Babylon War is Peace Ponzi Swamp economy; [B] require all citizens of all races, religions, nations, to breed and consume below ecological carrying capacity limits; or be humanely eliminated from the planetary genepool; [C] nationalize all property and provide all responsible freedom oath citizens: (i) with cultural law self rule for groups with subjective racial, religious & gender identities; and (ii) a property ration land reform to enable their shelter and survival self-sufficiency to enable the rebuilding of a relocalized low-tech organic agrarian sustainable future. I further confirm that if or when EoP SciCult law is implemented as international law, I shall cooperate and sign my responsible freedom oath.
