- [2.1] If or when the FEC decision is that it accepts Ecology of Peace law citizen voters – incorruptible by WiP law elections – votes and confirms Timothy McVeigh as EoP law voters US President; and accordingly recommends to all WiP Law Political Parties to make a formal enquiry into the EoP v WiP law voter issues; with the purpose of recommending a (a) formal State EoP Axis Oath office for officials and citizens to file their EoP Axis Alliances Oaths; or (b) an EoP v WiP law referendum to enable formal EoP v WiP law voting resolution on the EoP v WiP law voter issues in dispute.

[A] An EoP Axis oath [eop-axis-oath<sup>21</sup>] is a promise – a form of labour or information barter exchange reciprocity [Dmitry Orlov Twilight of the Antipodes<sup>22</sup>] – purchase of labour or information sharing cooperation with very clear unambiguous honest communication as to what the collective strategic goal is. If or when there is a mutual overlap agreement on strategic goal between two or more individuals, they can sign an unconditional or conditional cooperator oath, to clarify the level of their unconditional or conditional cooperator commitment to the strategic goal. The oath is a process to learn to practice in decision-making, communication and relating responsible freedom self government 24/7/365: If or when my ego gets in the way of me cooperating, towards our strategic goal; I will not run away or play some passive aggressive egomindfuck games. I will be my own or your Sgt Major and bitch slap my own or your fragile ego Private through the face with clear sincere verbal feedback, to help quick resolution of our misunderstanding, disagreement with you my fellow Oath co-operator; to enable us to uphold our cooperation agreement towards our shared strategic goal, through potentially difficult times. It's a statement of: our strategic goal is our cooperative master, not our individual ego's.

[12] Unconditional Co-operator Oath:

- [12.1] An unconditional co-operator oath confirms the oath takers commitment to unconditional ego-eco literacy EoP TRC strategic and tactical negotiations cooperation; towards the EoP UN Resolution strategic global and national security goal.
- [12.2] EoP MILED Clerk's citizen oath [pp.29-33/143] provides a template for an unconditional co-operator oath, made by an official or citizen prior to the implementation of EoP Scientific and Cultural Law.
- [12.3] Responsible Freedom Oath [pp.94-95/143] provide a draft template of the responsible freedom oath, that all citizens will be required to sign, subsequent to implementation of EoP Scientific and Cultural Law as international law.

[13] Conditional Co-operator Oath Statement:

[B] United States Government: Dept of Justice Attorney General:

a. To authorize the NSA: Gen Paul Nakasone and/or Timothy McVeigh's NSA superior; to enter into negotiations with South African and Russian Federation officials to arrange for the logistics for Timothy McVeigh to travel to South Africa and to Russia with applicant for their joint assisted suicide in Siberia.

[C] South African Government: DIRCO: Dept of International Relations and Cooperation:

a. To grant Timothy McVeigh a visa to travel from America to Russia via South Africa, to accompany applicant for their joint assisted suicide in Siberia.

[D] Russian Federation Government: Ministry of Foreign Affairs:
